

# Awana 60<sup>th</sup> Anniversary Video Contest Official Terms and Conditions

TO ENTER, YOU MUST COMPLETE THE REGISTRATION FORM, READ THE VIDEO CONTEST OFFICIAL TERMS AND CONDITIONS ("Terms and Conditions") BELOW AND AGREE TO THE OFFICIAL TERMS AND CONDITIONS AND OTHER WEB SITE TERMS BY CLICKING THE ACCEPTANCE BOXES WHERE INDICATED AND THEN CLICKING ON THE "SUBMIT" BUTTON. SUBJECT TO ALL FEDERAL, STATE AND LOCAL LAWS AND REGULATIONS. VOID OUTSIDE OF THE 50 STATES (INCLUDING THE DISTRICT OF COLUMBIA) OF THE UNITED STATES AND WHERE PROHIBITED BY LAW. NO PURCHASE NECESSARY.

**1. CONTEST SCHEDULE.** The Awana Video Contest (referred to herein as "the Contest") commences at 12:00 a.m. Central Time on September 1, 2010, and ends at 11:59:59 p.m. Central Time on October 17, 2010 (referred to herein as the "Contest Period"). Entries received after the deadline will not be considered. The Voting Period commences at 12:00 a.m. Central Time on November 1, 2010 and ends at 11:59:59 p.m. on November 12, 2010 ("Voting Period").

**2. ELIGIBILITY.** The Contest is open only to churches located in the fifty (50) United States and the District of Columbia and individuals who are legal residents of the fifty (50) United States and the District of Columbia who are age 18 or older at the time of entry.

Staff, officers, and board members of Awana Clubs International (referred to here as "ACI") and their immediate family members (spouse and parents, siblings and children and their spouses) and individuals living in the same households of each of the above are ineligible.

**3. HOW TO ENTER.** Visit [www.awana60years.org/videocontest](http://www.awana60years.org/videocontest) during the Contest Period, to complete the Entry Form online. Each entry will consist of one completed Entry Form and Video. The Entry Form must contain the YouTube .url address of the video. An Entrant may enter the Contest as many times as desired, provided each video submitted is unique. However, there is a limit of one (1) prize per church, individual or household. The video must not be longer than 60 seconds in length, unless the video consists of singing the Awana theme song, in which case the video has no time limit. All Entries must be submitted in English. Videos that exceed these time limitations will be disqualified. Videos will be accepted for the following categories:

- 1st category: How Awana has impacted my church
- 2nd category: How Awana has impacted me
- 3rd category: How Awana has impacted my children
- 4th category: Sing the Awana theme song

You must complete the following steps:

A. Register on YouTube: If you are not an existing user of YouTube, you will be required to create a free user account at <http://www.youtube.com/signup>. Registration on YouTube must be completed before a video can be submitted. When you register your YouTube account, you will be required to agree to the YouTube Terms of Use, located at <http://www.youtube.com/t/terms>, and the YouTube privacy policy, located at <http://www.youtube.com/t/privacy>.

B. Upload your video submission: Once registered with YouTube, upload your video, and make note of the .url address on your online Entry Form. Entries that do not include all required information and adhere to these requirements will be considered void and will not be considered in the judging of this Contest.

**4. WARRANTIES AND RELEASES.** By entering, each entrant represents and warrants that the video: (a) is her/her original work, and (b) does not violate the copyright or any other personal or property right of any third party. In addition, each entrant represents and warrants that s/he has obtained the releases necessary from any person(s) participating in the video in any way and that all rights to the video shall belong to ACI. Any entrant selected as a finalist must also sign and return to ACI Video and Publicity Release Form(s) (where legally permissible). The following persons must also sign and return to ACI a Video and Publicity Release Form (where legally permissible): any person who owns an interest in the Video, any person filming, producing, or editing the Video, and any person whose appearance or voice is incorporated into the Video. The Entrant must also provide proof that Entrant has the right to use any intellectual property incorporated into the Video, such as photographs, video footage, music tracks, and the like. If any of the above persons are minors, then written consent must be obtained from the minor's parent or guardian. If Entrant does not provide Video and Publicity Release Forms from all of the above persons and proof of rights to use intellectual property incorporated into the Video, Entrant will not be eligible to be a finalist, a category Grand Prize winner or category First Place winner, as the case may be. **5. VIDEO RIGHTS.** All contest entries become the sole property of ACI, and will not be acknowledged or returned. ACI thereby has the right to edit, adapt, modify, reproduce, promote and otherwise use Entries in any way ACI sees fit in any medium, throughout the world, in perpetuity. Each entrant agrees that ACI shall have the right, without further compensation, to publicize and/or broadcast his or her name, voice, likeness, church name and the fact that he or she won the contest. Entrants further agree that Awana Clubs International may use such identifying information to publicize its programs, website and other contests.

**6. JUDGING CRITERIA.** ACI will select finalists based upon the following criteria: creativity, ability to inspire, and interpretation of theme. ACI will post all entries, including finalists, at [www.awana60years.org/videocontest](http://www.awana60years.org/videocontest). Entrants chosen to be Finalists will be notified, and must return completed Video and Publicity Release Forms prior to October 27, 2010. If completed Video and Publicity Release forms are not received by ACI prior to October 27, 2010, Entrant will be ineligible to be a Finalist, and a new Finalist will be selected. The Voting Period will be November 1 through November 12, 2010. Those visiting [www.awana60years.org/videocontest](http://www.awana60years.org/videocontest) during the voting period will be able to view the videos and cast one vote per category per day among the finalists in each category. Voters can vote one time per category per day throughout the voting period. Finalist Videos in each category receiving the highest number of favorable votes will be the category Grand Prize winners, and the Finalist Video receiving the next-highest number of favorable votes will be the category First Place winners. Entrants may not attempt to obtain votes by offering any item of value in exchange for votes. ACI may prohibit an Entrant from participating in the Contest or winning a prize if, in its sole discretion, it determines an Entrant is attempting to undermine the legitimate operation of the Contest by cheating, hacking, deception or other unfair practices or intending to annoy, abuse, threaten or harass any other Entrant or ACI's representatives. ACI in its sole discretion may immediately disqualify any Entrant who it believes has engaged in such activity. Entries that include inappropriate language and/or behavior will be immediately disqualified. At the end of the Contest Entry Period, for each of the four categories, one Entrant will be selected as the category Grand Prize winner and one entrant

as the category First Place winner. If an insufficient number of qualified Entries are received during the Contest Period (as determined by the judges), the Contest will be cancelled and prizes will not be awarded.

**7. PRIZES AND VALUE.** Eligibility, age and prize claim by prize winners is subject to verification. The winners will be notified by e-mail and/or telephone no later than November 16, 2010. If a prize winner notification is undeliverable, or a prize winner ineligible, the prize will be forfeited and awarded to the next highest scoring Entry. Grand Prize and First Prize will be awarded in each category. Grand prize for individual entrants shall be an Awana® 60<sup>th</sup> Prize Pack (valued at \$42.00) along with either a Samsung Blu-Ray Disc™ player and power cord (valued at \$240.00) or Flip Video Camcorder™ (valued at \$150.00). The individual grand prize is valued at no more than \$282.00. Grand prizes in each category for church entrants shall be one complimentary Awana® annual church registration or account credit of equivalent value (valued at \$99.00) along with either a Samsung Blu-Ray Disc™ player and power cord (valued at \$240.00) or Flip Video Camcorder™ (valued at \$150.00).
